Shropshire Junior League

The SJFL provides organised football for U8's to U16's boys. There are currently 20 clubs who are all Charter Standard clubs, administrating football for 169 teams. There are 2300+ players registered to play. The SJFL promote non-competitive Development football at U8 to U11 with U12 Development football competitive. The U13-U16 are open competition. SJFL have 3 Cup Competitions including a Charity Cup and also hold U10's & U11's Festivals in a Champions League format. During the winter break the SJFL host a Futsal Festival for U8's to U10's teams, which is in its 8th year and over 60 teams in attendance.

They currently use the FA Full -Time & SMS Texting system for fixtures, match & Respect reporting for all teams. Next season they will use FA FT for referee appointments. The SJFL currently appoint referees at U13, U14 & U16 and next season will add the U15's. They fund referee courses & next season we will appoint a FA Referee Observer/Mentor to help with new referees. SJFL were proud to be the first in Shropshire/West Midlands region to be a National Referee Development Partner League.

Shrewsbury Town Council presents the Mayor of Shrewsbury's Awards annually to individuals, schools or organisations within Shrewsbury in recognition of their achievements towards enhancing the wellbeing of young people in the area and The SJFL has been recognised and selected to receive the Gold award in the Youth Category for excellence in its class. Members of the Council used some of the extract criteria below in selecting the league's nomination.

SJFL has come a long way since it started in the 1973/74 season with just 25 teams in 3 divisions for U13, U14 & U16 age groups and less than 300 players. In 2014 SJFL celebrated 40 years of providing junior football shropshirejuniorleague.co.uk/sjfl40 with a turnover of £20,000+, 23 FA Charter Standard clubs, 167 teams from U8 to U16 and 2300+ players.

As an affiliated Respect League, SJFL was recognised for its excellent work with Respect and was awarded The Bronze accreditation by The FA in 2012 and in 2013 with the FIRST Silver accreditation to any league in the county. 2009 was a big year, starting with SJFL becoming the FIRST affiliated league in England to be accredited as Charter Standard by The F.A with a presentation at Wembley Stadium and finished at the league's Futsal Festival held at Shrewsbury Sports Village with a presentation by the Mayor of Shrewsbury for services to football in the community. In 2014 The Georgia Williams Trust became the league's new 'Respect Partners' supporting and promoting the Respect Programme. Shrewsbury Juniors

Shrewsbury Juniors continue to work very hard as a club to provide the best environment for everyone to enjoy. Everyone within the club work tirelessly to continue to improve, at the start of the season the club boasted 29 teams. The club has doubled in size in the past three years, and now have 40 children regularly attending the club's crèche. SJSFC have now started running a girl's only training night, looking to start new under 8's and under 10's teams for the 2016/2017. With the creation of these new teams, the club are looking to provide football for 34 teams next season.

This summer Shrewsbury Juniors are very excited to be starting their first men's adult team, playing in the Mercian Regional League. The ladies team continues to develop well in the midlands league. The club support their coaches, with one female coach currently in the process of completing her UEFA B badge. Numerous coaches are currently completing their level 2 coaching badge and goalkeeper level 1 and 2's. This is then used to deliver specific goal keeper training each week, open to the community.

SAFE GUARDING CHILDREN

It is the aim of the Shropshire Junior Football League (league) to ensure that every child or young person who plays football within this 'league' should be able to participate in an enjoyable and safe environment and be protected from abuse. A child or young person is anyone under the age of 18 engaged in any footballing activity (including match officials).

All adults associated with this 'league' are to safeguard the welfare of all players and where possible protect them from physical, sexual and emotional harm and from neglect and bullying.

In striving to attain this 'The League's' aims are as follows:

- To ensure that the child's welfare is always considered as paramount.
- All young people involved in football have a right to be protected from abuse and harm regardless of their sporting ability, age, gender, disability, culture, language, racial origin, religious beliefs or sexual identity.
- The League will treat all suspicions and allegations of abuse and poor practice seriously and will respond swiftly and appropriately.
- To ensure that all member clubs appoint a Club Welfare Officer

The requirements of this post will be in line with FA recommendations which include as a minimum:

- a) obtaining an up to date FA accredited DBS Enhanced Disclosure which must be kept up to date and renewed every 3 years.
- b) attendance at an FA 'Safeguarding Children Workshop and subsequent resultant certification which must be kept up to date and renewed every 3 years.
- c) Attendance at an ` FA Welfare Officers Workshop`.

- To encourage all member clubs to attain FA Charter Standard status.
- To actively encourage people to take advantage of educational opportunities provided by the FA in the area of Child Protection and best practice.
- To provide a structured network of support to its membership if and when required in areas relating to Child Protection issues.
- To develop pro-active and positive ethics to support the above aims.

This guide provides extracts from the Laws of mini-soccer for Under 7 - Under 10 versions of the game, with children playing a maximum of 7v7 (see Rule8 (C)).

Except where other provision, in these Laws are made, the Laws of Association Football apply. These Laws are mandatory unless special permission is granted by The FA. www.TheFA.com/youthdevelopmentreview

From season 2014/15 Under 7 - U10s are not permitted to play in leagues where results are collected or published or winner trophies are presented (see Rule 11(D)). This is deemed to be detrimental to the development of the player and the game and will not be sanctioned. Under 7-10s can play in a maximum of three trophy events during the season, lasting a maximum of four weeks each. These are short-term experiences helping children learn about winning and losing in an appropriate environment. The winners of these events can be published and trophies can be presented.

RECOMMENDED PITCH SIZE & MARKINGS:

Under 8's

Length : Max 45.75 metres (50 yards) Min 27.45 metres (30 yards)

Width : Max 27.45 metres (30 yards) Min 18.30 metres (20 yards)

Under 9's & 10's

Length : Max 54.90 metres (60 yards) Min 45.75 metres (50 yards)

Width : Max 36.60 metres (40 yards) Min 27.45 metres (30 yards)

Penalty Area

Length : 9.15 metres (10 yards) Width : 16.46 metres (18 yards)

Penalty Mark

The penalty mark is 7.32 metres (8 yards) from the goalline opposite the centre of the goal.

Goal Size

The distance between the goals is 3.6 metres (12 feet) and the distance between the lower edge of the crossbar and the ground is 1.88 metres (6 feet).

Corner Flag post

Corner flag posts are compulsory. Flag posts must not be less than 1.5 metres (5 feet) high with a non-pointed top.

Playing Equipment

Players must wear shinguards at all times which must be covered entirely by the stockings and goalkeepers must wear a distinguishing playing strip

Age Group qualification of player

(see Rule 8(C))

Duration of play

(see Rule 10 Aiii)

Ball Size

(see table on rule 8C)

Start of Play

Opponents must be 4.5 metres (5 yards) away from the ball

Offside

There are no offside.

Freekicks

In Mini Soccer all freekicks are direct. Opponents must be 4.5 metres (5 yards) from the ball.

Penalty kicks

All players except the defending goalkeeper and the kicker must be outside the penalty area and at least 4.5 metres (5 yards) from the penalty mark.

Goal kicks

A player of the defending team kicks the ball from any point within the penalty area. Opponents must retreat to their own half until the ball is in play. The defending team does not have to wait for the opposition to retreat and has the option to restart the game before should they choose to. The ball is in play when it is kicked directly out of the penalty area.

Throw In

A goal cannot be scored direct from a throw-in. The throw-in is the normal overhead throw.

Substitutions

Roll on, roll off substitution is allowed when the ball is out of play and with the agreement of the referee.

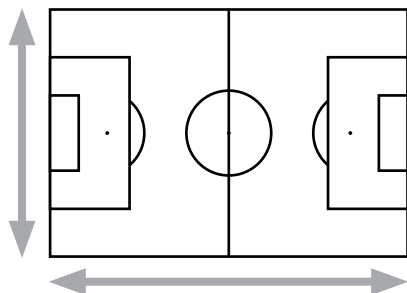

MEMBERSHIP RULES

STANDARD CODE OF RULES FOR MINI SOCCER AND YOUTH FOOTBALL COMPETITIONS

This document contains the Standard Code of Rules developed by The Football Association, for Mini Soccer and Youth Football Competitions. Such Competitions may add to the core of the Standard Code, which is mandatory, providing the additions are approved by the sanctioning Association and do not conflict with the mandatory Rules or any relevant principles and policies established by The FA. Guidance from the sanctioning Association should be sought in advance if there is any doubt as to the acceptability of additional Rules.

This Standard Code of Rules is mandatory for all Mini Soccer and Youth Football Competitions. Mini Soccer and Youth Football Competitions seeking sanction must draft their Rules in conformity with the code putting them in the correctly numbered Rule and showing the standard heading. The mandatory element is printed in normal text and the optional elements in italics.

It should be noted that in many cases Rules are so printed because they are alternatives and the procedure to apply should be retained and the others omitted. In all cases where a line is shown the necessary name, address, number or wording to complete this Rule must be inserted.

DEFINITIONS

1. (A) In these Rules:

“Affiliated Association” means an Association accorded the status of an affiliated Association under the Rules of The FA.

“AGM” shall mean the annual general meeting held in accordance with the constitution of the Competition.

“Club” means a Club for the time being in membership of the Competition.

“Competition” means the Shropshire Junior Football League.

“Competition Match” means any match played or to be played under the jurisdiction of the Competition.

“Contract Player” means any Player (other than a Player on a Scholarship) who is eligible to play under a written contract of employment with a Club.

“Deposit” means a sum of money deposited with the Competition as part of the requirements of membership of the Competition.

“Fees Tariff” means a list of fees approved by the Clubs at a general meeting to be levied by the Management Committee for any matters for which fees are payable under the Rules.

“Fines Tariff” means a list of fines approved by the Clubs at a general meeting to be levied by the Management Committee for any breach of the Rules.

“Ground” means the ground on which the Club's Team(s) plays its Competition Matches.

“Management Committee” means in the case of a Competition which is an unincorporated association, the management committee elected to manage the running of the Competition and where the Competition is incorporated it means the Board of Directors appointed in accordance with the articles of association of that company.

“Match Officials” means the referee, the assistant referees and any fourth official appointed to a Competition Match.

“Mini Soccer” means those participating at ages under 7s to under 10s.

“Non Contract Player” means any Player (other than a Player on a Scholarship) who is eligible to play for a Club but has not entered into a written contract of employment.

“Officer” means an individual who is appointed or elected to a position in a Club or Competition which requires that individual to make day to day decisions.

“Participants” means an Affiliated Association, Competition, Club, Club Official, Intermediary, Player, Official, Match Official, Management Committee member, member or employee of an Affiliated Club and all such persons who are from time to time participating in any activity sanctioned either directly or indirectly by the Association.

“Player” means any Contract Player, Non Contract Player or other player who plays or who is eligible to play for a Club.

“Playing Season” means the period between the date on which the first competitive fixture in the Competition is played each year until the date on which the last competitive fixture in the Competition is played.

“Rules” means these rules under which the Competition is administered.

“Sanctioning Authority” means [The FA] the Shropshire County Football Association Limited].

“Scholarship” means a Scholarship as set out in Rule C 3 (a) (i) of the Rules of The FA.

“Secretary” means such person or persons appointed or elected to carry out the administration of the Competition.

“Team” means a team affiliated to a Club.

“Team Sheet” means a form provided by the Competition on which the names of the Players taking part in a Competition Match are listed.

“The FA” means The Football Association Limited.

“written” or **“in writing”** means the representation or reproduction of words or symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise.

“Youth Football” means those participating at ages under 11s to under 18s.

(B) All Clubs shall adhere to the Rules. Every Club shall be deemed, as a member of the Competition to have accepted the Rules and to have agreed to abide by the decisions of the Management Committee in relation thereto, subject to the provisions of Rule 16.

(C) The Competition will be known as [Shropshire Junior Football Clubs] (or such other name as the Competition may adopt). The Clubs participating in the Competition must be members of the Competition. A Club which ceases to exist or which ceases to be entitled to play in the Competition for any reason whatsoever shall thereupon automatically cease to be a member of the Competition.

(D) The administration of the Competition under these Rules will be carried out by the Competition acting (save where otherwise specifically mentioned herein) through the Management Committee in accordance with the rules, regulations and policies of The FA.

(E) Unless stated otherwise, terms referring to natural persons are applicable to both genders. Any term in the singular applies to the plural and vice-versa.

NAME AND CONSTITUTION

2.(A) This Competition shall consist of not more than 50 Clubs approved by the Sanctioning Authority.

(B) All Clubs must be affiliated to an Affiliated Association and their names and particulars shall be returned annually by the appointed date in a manner prescribed by the Sanctioning Authority and must have a constitution approved by the Sanctioning Authority. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff). The area covered by the Competition membership shall be 32 miles of the Leagues headquarters.

This Competition shall apply annually for sanction to the Shropshire County Football Association(s) and the constituent Teams of member Clubs may be grouped in divisions, each not exceeding 10 in number.

(C) Inclusivity and Non-discrimination

(i) The Competition and each member Club must be committed to promoting inclusivity and to eliminating all forms of discrimination and should abide and adhere to The FA Equality Policy and any legislative requirements (to include those contained in the Equality Act 2010).

(ii) This Competition and each member Club must make every effort to promote equality by treating people fairly and with respect, by recognising that inequalities may exist, by taking steps to address them and by providing access and opportunities for all members of the community, irrespective of age, gender, gender reassignment, sexual orientation, marital status, race, nationality, ethnic origin, colour, religion or belief, ability or disability or otherwise.

(iii) Any alleged breach of the Equality Act 2010 legislation must be referred to the appropriate Sanctioning Authority for investigation.

(D) Clubs must comply with the provisions of any initiatives of The FA which are adopted by the Competition including but not limited to, Charter Standard and RESPECT programmes. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(E) Clubs shall not enter any of their Teams playing at a particular age group in the Competition in any other competition (with the exception of FA and County FA Competitions) except with the written consent of the Management Committee. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(F) At the AGM or a Special General Meeting called for the purpose, a majority of the delegates present shall have power to decide or adjust the compilation of the divisions at their discretion. When necessary this Rule shall take precedence over Rule 12.

(H) Local Rule: Cup Competitions – Shropshire Charity Cup.

The entire control & management of the Competition shall be vested in the Management of the Telford Junior Youth League & the Shropshire Junior Football League. The Competition shall be open to Clubs affiliated to the Shropshire Football Association & shall be competed for annually & cannot be won outright. All member teams shall be automatically entered into the competition. Teams not wishing to enter should notify the League Secretary no later than the 1st September. The SJFL will administer the U13 & U14 age groups & the TJYL will administer the U12, U15 & U16 age groups. Both Leagues will administer their own U10 & U11 age groups. Each Leagues rules shall apply unless specifically stated otherwise in these Rules.

(I) Local Rule: Clubs or teams seeking membership & residing or playing in the Wrekin Division & South Shropshire Division (Defined as the Shropshire FA Constituency Boundaries) will not be accepted into this Competition unless sanctioned by the Telford Junior & Youth Football League, South Shropshire Junior Football League & the Shropshire FA Football Development Committee.

(J) Local Rule: *The Football Association Child Protection Procedures & Practice Handbook establishes the Football Association's Position, role & responsibilities & together with the Procedures Handbook clarifies what is expected of other organisations (Shropshire Junior Football League) & individuals (all registered clubs & their members) involved in football. The policy clearly Highlights the importance placed by the Football Association on the protection of children & young people who participate in Football at all levels.*

(K) Local Rule: *All member clubs must appoint a Club Welfare Officer to ensure compliance with Rule 2 (C) & to encourage Compliance with recommendations as detailed in Rule 2 (ii). Appointed Club Welfare Officers must hold a current FA DBS Unit Enhanced Disclosure before he/she can be elected as Club Welfare Officer. In addition, within three months of Appointment he/she must have attended/applied to attend the FA Welfare Officer Workshop & Safeguarding Children Workshop.*

(L) Local Rule: *The information provided under Rule 3E will be given on the prescribed forms & must also include details of each Age group team's manager & assistant. Valid telephone/mobile number & email address must be included. No named persons can be named as manager or assistant for more than one team. Failure to comply will result in the matter being dealt with by the SJFL Management Committee.*

ENTRY FEE, SUBSCRIPTION, DEPOSIT

3.(A) Applications by Clubs for admission to this Competition or the entry of an additional Team(s) from the same Club must be made in writing to the Secretary and must be accompanied by an entry fee £30 set out in the Fees Tariff per Team which shall be returned in the event of non-election.

At the discretion of the voting members present applications, of which due notice has been given, may be received at the AGM or a Special General Meeting or on a date agreed by the Management Committee.

(B) An annual subscription shall be payable in accordance with the Fees Tariff per Club (or per Team where a Club provides more than one Team in membership of the Competition) and shall be payable on or before 31st July in each year.

£30 per team playing 11 aside football, £25 per team playing 9 v 9 football & £20 per team playing mini soccer.

(C) A Deposit of £25 shall be payable per Club (or per Team where a Club provides more than one Team in membership of the Competition) and shall be payable on or before 30th June in each year. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(D) A Club shall not participate in this Competition until the entry fee, annual subscription and Deposit (if required) have been paid.

(E) If requested by the Competition, Clubs must advise annually to the Secretary in writing by 1st September of its Sanctioning Authority affiliation number for the forthcoming Playing Season, failing which they shall be fined (in accordance with the Fines Tariff).

Clubs must advise the Secretary in writing, or on the prescribed form, of details of its headquarters, Officers and any other information required by the Competition.

(F) Local Rule *For the purpose of the Shropshire Charity Cup the fees of £10 per team will apply.*

MANAGEMENT, NOMINATION, ELECTION

4.(A) The Management Committee shall comprise the Officers of the Competition and members who shall all be elected at the AGM. All Participants shall abide by The Football

Association Regulations for Safeguarding Children as determined by The FA from time to time.

(B) Retiring Officers shall be eligible to become candidates for re-election without nomination provided that the Officer notifies the Secretary in writing not later than April in each year.

All other candidates for election as Officers or members of the Management Committee shall be nominated to the Secretary in writing, signed by the secretaries of two member Clubs, not later than April in each year. Names of the candidates for election shall be circulated with the notice of the AGM. In the event of there being no nomination in accordance with the foregoing for any office, nominations may be received at the AGM.

(C) The Management Committee shall meet as and when required, save that no more than three calendar months shall pass between each meeting.

On receiving a requisition signed by two-thirds (2/3) of the members of the Management Committee the Secretary shall convene a meeting of the Management Committee.

(D) Except where otherwise mentioned all communications shall be addressed to the Secretary who shall conduct the correspondence of the Competition and keep a record of its proceedings.

(E) All communications received from Clubs must be conducted through their Officers and sent to the Secretary.

Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(F) Local Rule: *All communication shall be addressed to the League Secretary with the exception to relevant sensitive matters must be sent/communicated to the League Welfare Officer.*

(G) Local Rule: *The Management Committee shall not include more than four members from one club.*

(H) Local Rule: *The League shall hold monthly meetings which shall consist of the Officers of the League Management Committee Members & one representative from each member club who will be entitled to vote (eight to form a quorum). The monthly meetings will be normally held on the second Monday of each month at the League Headquarters. Any club failing to be represented shall be fined as per rule tariff. Any Club failing to attend two meetings in succession will be dealt with by the Management Committee & liable to be fined under Rule 5H. Not less than seven days' notice shall be given of any meeting.*

POWERS OF MANAGEMENT

5.(A) The Management Committee may appoint sub-committees and delegate such of their powers as they deem necessary. The decisions of all sub-committees shall be reported to the Management Committee for ratification. The Management Committee shall have power to deal only with matters within the Competition and not for any matters of misconduct that are under the jurisdiction of The FA or Affiliated Association.

(B) Subject to the permission of the Sanctioning Authority having been obtained the Management Committee may order a match or matches to be played each season, the proceeds to be devoted to the funds of the Competition and, if necessary, may call upon each Club (including any Club which may have withdrawn during the season) to contribute equally such sums as may be necessary to meet any deficiency at the end of the season.

(C) Each member of the Management Committee shall have the right to attend and vote at all Management Committee meetings and have one vote thereat, but no member shall be allowed to vote on any matters directly appertaining to such member or to the Club so represented or where there may be a conflict of interest. (This shall apply to the procedure of any sub-committee).

In the event of the voting being equal on any matter, the Chairman shall have a second or casting vote.

(D) The Management Committee shall have powers to apply, act upon and enforce the Rules of the Competition and shall also have jurisdiction over all matters affecting the Competition. Any action by the Competition must be taken within 28 days of the Competition being notified.

With the exception of Rules 6(H) and 19, and subject to Rule 5(I), in relation to any alleged breaches of a Rule the Management Committee shall issue a formal written charge to the Club concerned. The Club charged is required to respond to the charge within 7 days from the date of notification of the charge. In such reply a Club may:-

(i) Accept the charge and submit in writing a case of mitigation for consideration by the Management Committee on the papers; or

(ii) Accept the charge and notify that it wishes to put its case of mitigation at a hearing before the Management Committee; or

(iii) Deny the charge and submit in writing supporting evidence for consideration by the Management Committee on the papers; or

(iv) Deny the charge and notify that it wishes to put its case of mitigation at a hearing before the Management Committee.

Where the Club charged fails to respond within 7 days, the Management Committee shall determine the charge in such manner and upon such evidence as it considers appropriate.

Where required, hearings shall take place as soon as reasonably practicable following receipt of the reply of the Club as more fully set out above.

Having considered the reply of the Club (whether in writing or at a hearing), the Management Committee shall make its decision and, in the event that the charge is accepted or proven, decide on the appropriate penalty (with reference to the Fines Tariff where applicable).

The maximum fine permitted for any breach of a Rule is £100 and, when setting any fine, the Management Committee must ensure that the penalty is proportional to the offence, taking into account any mitigating circumstances. No Participant under the age of 18 can be fined.

All breaches of the Laws of the Game, Rules and Regulations of The FA shall be dealt with in accordance with FA Rules by the appropriate Association.

(E) All decisions of the Management Committee shall be binding subject to the right of appeal in accordance with Rule 16.

Decisions of the Management Committee must be notified in writing to those concerned within 10 days.

(F) [%] of its members shall constitute a quorum for the transaction of business of the Management Committee or any sub-committee thereof.

(G) The Management Committee, as it may deem necessary, shall have power to fill, in an acting capacity, any vacancies that may occur amongst their number.

(H) A Club must comply with an order or instruction of the Management Committee, and must attend to the business and/or the correspondence of the Competition to the satisfaction of the Management Committee. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(I) Subject to its right of appeal in accordance with Rule 16 below, all fines and charges shall be paid within 14 days of the date of posting of notification of the decision.

Any Club failing to do so will be fined (in accordance with the Fines Tariff). Further failure to pay the fine including the additional sum within a further 14 days will result in fixtures being withdrawn until such time as the outstanding fines are paid.

(J) A member of the Management Committee appointed by the Competition to attend a meeting or match may have any expenses incurred refunded by the Competition.

(K) The Management Committee shall have the power to fill any vacancy that may occur in the membership of the Competition between the AGM or Special General Meeting called to decide the constitution and the commencement of the Competition Playing Season.

(L) The business of the Competition as determined by the Management Committee may/shall be transacted by electronic mail or facsimile.

(M) Local Rule The SJFL Management Committee have the power to charge expenses with the necessary fines as laid down in the Rules of the Shropshire Junior Football League.

(N)(i) Local Rule For the purpose of all Cup Competitions. All questions of eligibility, qualification of Competition etc., shall be referred to the Management Committee, whose decision will be final, subject to Rule 15 & any protest must be accompanied by a deposit of £10 which shall be forfeited. Any protest must be lodged in duplicate with the League Secretary postmarked within 72 hours of the completion of the fixture to which the protest refers.

Any club not satisfied with the decision of the Management Committee has the right to appeal to the Shropshire FA as per Rule 15 F.

(ii) Clubs entering the Charity Cup Competition must raise money for the Charity Cup Competition (by draws or donations) & the proceeds submitted to the League Secretary for distribution to the nominated charities.

(iii) The team winning the Competition trophy will insure its value & sign to cover any loss or damage. Any trophy must be returned engraved & in a good clean condition.

ANNUAL GENERAL MEETING

6. (A) The AGM shall be held not later than the 15th June in each year. At this meeting the following business shall be transacted provided that at least one third of members are present and entitled to vote: -

(i) To receive and confirm the Minutes of the preceding AGM.

(ii) To receive and adopt the Annual Report, Balance Sheet and Statement of Accounts.

(iii) Election of Clubs to fill vacancies.

(iv) Constitution of the Competition for ensuing Playing Season.

(v) Election of Officers and Management Committee.

(v)(a) Local Rule Term Of Office.

President – 1-year term 2015/16 then 3-year term of office on a 3-year election cycle.

Chairman – 1-year term of office 2015/16 then 3-year term of office on a 3-year election cycle.

Vice-Chairman – 1- year term of office 2016/17.

Secretary – 3-year term of office 2015/16 to 2017/18 then 3-year term of office on a 3-year election cycle.

Assistant Secretary – 1-year term of office 2015/16.

Treasurer – 3-year term of office 2015/16 to 2017/18 then 3-year election cycle.

Fixture Secretary – 2-year term of office 2015/16 to 2016/17 then 3-year election cycle.
 Registration Officer Youth – 2-year term of office 2015/16 to 2016/17 then 3-year election cycle.
 Registration Officer Mini Soccer- 1-year term of office 2016/17.
 Referees Appointment Officer- 3-year term of office 2016/17 then on a 3-year election cycle.
 Referee Mentor Officer – 1-year term of office 2016/17.
 Welfare & RESPECT Officer – 1-year term of office 2016/17.
 SJFL Delegate to SFA – 1-year of office 2016/17.
 SJFL Delegate to A/RDO – 1-year term of office 2016/17.
 FA Full-Time Administrator- 1-year term of office 2016/17.

(vi) Appointment of Auditors.

(vii) Alteration of Rules, if any (See Rule 20).

(viii) Fix the date for the commencement of the Playing Season and kick off times applicable to the Competition.

(ix) Fix the date for the end of the Playing Season.

(x) Other business of which due notice shall have been given and accepted as being relevant to an AGM.

(B) A copy of the duly audited/verified Balance Sheet, Statement of Accounts and Agenda shall be forwarded to each Club at least 14 days prior to the meeting together with any proposed changes.

(C) A signed copy of the duly audited/verified Balance Sheet and Statement of Accounts shall be sent to the Sanctioning Authority within 14 days of its adoption by the AGM.

(D) Each Club shall be empowered to send two delegates to an AGM. Each Club shall be entitled to one vote only. 14 days' notice shall be given of any Meeting.

(E) Clubs who have withdrawn their membership of the Competition during the Playing Season being concluded or who are not continuing membership shall be entitled to attend but shall vote only on matters relating to the Playing Season being concluded. This provision will not apply to Clubs expelled in accordance with Rule 17.

(F) All voting shall be conducted by a show of voting cards unless a ballot be demanded by at least 50% of the delegates qualified to vote or the Chairman so decides.

(G) No individual shall be entitled to vote on behalf of more than one-member Club.

(H) Any continuing Club must be represented at the AGM. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(I) Officers and Management Committee members shall be entitled to attend and vote at an AGM.

(J) Where a Competition is an incorporated entity, the Officers of the Competition shall ensure that the Articles of Association of the Competition are consistent with the requirements of these Rules.

(K) Local Rule: All Leagues, Competitions and Clubs registered with the Shropshire F.A shall, on or before 15th June each year, hold their AGM for election of officers and committee for the ensuing season. Clubs must inform the League Secretary of date of their AGM.

AGREEMENT TO BE SIGNED

7. Each Club shall complete and sign the following agreement which shall be deposited with the Competition together with the application for membership for the coming Playing Season, or upon indicating that the Club intends to compete.

"We, (A), (name) [] of (address) [] (Chairman)/Director and (B) (name) [] of (address) [] (Secretary/Director) of [] Football Club (Limited) have been provided with a copy of the Rules and Regulations of the [] Competition and do hereby agree for and on behalf of the said Club, if elected or accepted into membership, to conform to those Rules and Regulations and to accept, abide by and implement the decisions of the Management Committee of the Competition, subject to the right of appeal in accordance with Rule 16."

The agreement shall be signed by:

Where a Club is an unincorporated association, the Club Chairman and secretary; or

Where a Club is an incorporated entity, two directors of the Club.

Any alteration of the Chairman and /or secretary of the Club on the above agreement must be notified to the County Football Association(s) to which the Club is affiliated and to the Secretary.

Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

QUALIFICATION OF PLAYERS

8.(A)(i) A registered youth playing member of a Club is one who, being in all other respects eligible, has:-

Signed a fully and correctly completed Competition registration form in ink, countersigned by his /her parent or guardian and by an Officer of the Club, and who has been registered with the (Registrations) Secretary [] days prior to playing and whose completed registration counterfoil has been received by the Club prior to playing. The registration document must incorporate any known serious medical conditions of the Player and emergency contact details of the Player's parents or guardians. These details must be available at matches and training events the Player attends within the management of the Club or Competition.

Or

Signed a fully and correctly completed Competition registration form in ink on a match day prior to playing, countersigned by his/her parent or guardian and by an Officer of the Club and witnessed by an Officer of the opposing Club, and submitted to the (Registrations) Secretary within two days (Sundays excluded) subsequent to the match. The Player shall not again play until the Club is in possession of the completed counterfoil. A maximum of [] Players may be registered in this way. The registration document must incorporate any known serious medical conditions of the Player and emergency contact details of the Players' parents or guardians. These details must be available at matches and training events the Player attends within the management of the Club or Competition.

(ii) Registration forms may also be submitted to the (Registrations) Secretary by electronic mail or facsimile machine prior to the Player playing. The original document must be forwarded by post within three days of the match to the appropriate Officer.

The registration document must incorporate a current passport-size photograph of the Player seeking registration together with proof of the Player's date of birth.

If a Player's age is required for registration purposes a Competition must accept an original birth certificate or a photocopy. In cases where the birth certificate is not available a Competition is required to accept a photocopy of the Player's passport or other official document issued by a Government Agency attesting to the Player's date of birth.

Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(A) (iii) Local Rule: *The SJFL are piloting a FA Online Registration Process. All players will be registered by their clubs with the league via the Whole Game System.*

Players to be eligible to play the first game of the season must be approved & registered by the League Registration Secretary by the 1st of September. Any player whose registration has been submitted by the club after that date will not be processed until after the first games are played. After that date the deadline for any new players to be registered is 8.pm on the Thursday prior to the Sunday. A player will be deemed registered with his/her club when the player has been approved by the League Registration Secretary & the player is on the Team Player ID sheet.

It is the responsibility of the team manager to print off his Team ID sheet or show the opposing team manager on a mobile phone. Any player not shown on the ID sheet is not permitted to play. Any team not able to produce their Team ID sheet will be fined as per fine tariff.

(B)(i) Contract Players are not permitted in this Competition with the exception of those Players who are registered under contract with the same Club who have a Team operating at Steps 1 to 6 of the National League System.

It is the responsibility of each Club to ensure that any Player signing a registration form for that Club has, where necessary, the required International Transfer Certificate. Clearance is required for any Player aged 10 and over crossing borders including Wales, Scotland and Ireland.

(ii) A Player registered with a Premier League or Football League Academy under the Elite Player Performance Plan contained within Youth Development Rules will not be permitted to play in this Competition. Details of the Youth Development Rules are published on The FA website. A Player registered with a FA Girls' Regional Talent Club may play in this Competition subject to the FA Programme for Excellence (Female) Regulations.

(iii) Each Team must have the following number of Players registered 7 days before the start of each Playing Season:

Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(C) A child who has not attained the age of 6 shall not play, and shall not be permitted or encouraged to play, in a match of any kind.

The relevant age for each Player is determined by his or her age as at midnight on 31 August of the relevant Playing Season i.e. children who are aged 6 as at midnight on 31 August in a Playing Season (together with those who attain the age of 6 during the Playing Season) will be classed as Under 7 Players for that Playing Season. Children who are aged 7 as at midnight on 31 August in a Playing Season will be classed as Under 8 Players for that Playing Season, and so on.

Notwithstanding the above, a child is permitted to play up in the age group above his or her chronological age group, irrespective of any changes of format or competition structure, save

that a child who attains the age of 6 after 31 August is permitted to play only in the Under 7 age group, and may not play in the Under 8 age group, for that Playing Season.

The age groups that children are eligible to play in are set out in the table below, along with the permitted football formats for each of those age groups. Children shall not play, and shall not be permitted or encouraged to play, in a match between sides of more than the stated number of players, according to their age group:

(D) A fee as set out in the Fees Tariff shall be paid by each Club/Team for each Player registered, if applicable.

The SJFL Player Registration Fee is £2 per player.

(E) The Management Committee shall decide all registration disputes.

In the event of a Player signing a registration form or having a registration submitted for more than one Club priority of registration shall decide for which Club the Player shall be registered. The Secretary shall notify the Club last applying to register the Player of the fact of the previous registration.

(F) It shall be deemed a breach of these Rules for a Player to: -

(i) Play for more than one Club in the Competition in the same Playing Season without first being transferred.

(ii) Having signed for one Club in the Competition, sign for another Club in the Competition in that Playing Season, except for the purpose of a transfer.

(iii) Submit a signed registration form for registration that the Player had wilfully neglected to accurately or fully complete.

Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(iv) Local Rule: *A player registered with this league will not play more than one game in any one day including games &/or Competitions played on the same day outside the control of the Shropshire Junior Football League. Clubs within this League failing to comply will be liable to be fined as per rule tariff &/or otherwise penalised at the discretion of the Management Committee.*

(G)(i) The Management Committee shall have the power to accept the registration of any Player subject to the provisions of clauses (ii) and (iii) below.

(ii) The Management Committee shall have power to refuse, cancel or suspend the registration of any Player, the exercise of such power being without prejudice to the Management Committee's ability to fine a Club at its discretion (in accordance with the Fines Tariff) that has been charged and found guilty of registration irregularities (subject to Rule 16).

(iii) The Management Committee shall also have the power to refuse or cancel the registration of any Player charged and found guilty of undesirable conduct, such refusal or cancellation being subject to the right of appeal to the Sanctioning Authority. Where the Management Committee does not have enough information to enable it to make a decision pursuant to the above power, it may apply, in its absolute discretion, to the Sanctioning Authority or The FA for further information.

Undesirable conduct shall mean an incident of repeated proven misconduct, which may deter a Participant from being involved in this Competition.

(iv) For a Player who has previously had a registration removed in accordance with clause **(iii)** but has a registration accepted at the expiry of exclusion will be considered to be under a probationary period of 12 months. Whilst under a probationary period, should the Player commit a further act of proven misconduct under the jurisdiction of the Competition, (excluding standard dismissals), the Competition would be empowered to consider a further charge of bringing the Competition into disrepute.

(Note: Action under Clause (iii) shall only be taken against a Player in cases of the Player bringing the Competition into disrepute and will in any event be subject to an appeal to the Sanctioning Authority or The FA. All decisions must include the period of restriction. For the

purpose of this Rule, bringing the Competition into disrepute can only be considered where the Player has received in excess of 112 days' suspension, or 10 matches in match based discipline, in any competition (and is not restricted to the Competition) in a period of two years or less from the date of the first offence.)

(H) Subject to compliance with FA Rule C 2(a) when a Club wishes to register a Player who is already registered with another Club it shall submit a transfer form to the Competition accompanied by a fee as set out in the Fees Tariff. Such transfer shall be referred by the Competition to the Club for which the Player is registered. Should this Club object to the transfer it should state its objections in writing to the Competition and to the Player concerned within 7 days of receipt of the notification. Upon receipt of the Club's consent, or upon its failure to give written objection within 7 days, the Secretary may, on behalf of the Management Committee, transfer the Player who shall be deemed eligible to play for the new Club from such date or 7 days after receipt of such transfer.

In the event of an objection to a transfer the matter shall be referred to the Management Committee for a decision.

H (i) Local Rule: Any player who is deregistered by a club cannot register for another club for 14 days. The deregistering club must write to league to notify the league of the player's deregistration. The club must state if the player is clear of any outstanding liabilities & returned all kit.

(I) A Player may not be registered for a Club nor transferred to another Club in the Competition after the 31st January except by special permission of the Management Committee.

(J) A Club shall keep a list of the Players it registers and a record of the games in which they have played, and shall produce such records upon demand by the Management Committee.

In the event a Club has more than one Team in an age group, each Team must be clearly identifiable but not designated 'A' or 'B' or 1st or 2nd. In such cases, Players will be registered for one Team only. A Player so registered will be allowed to play for his Club in a younger or older age group within the provisions of Rule 8(C).

(K) A register containing the names of all Players registered for each Club, with the date of registration, shall be kept by the Registrations Secretary and shall be open to the inspection of any duly appointed member Club representative at all Management Committee meetings or at other times mutually arranged. Registrations are valid for one Playing Season only.

In the event of a Non Contract Player changing his status to that of a Contract Player with the same Club, another Club in the Competition or with a Club in another Competition his registration as a Non Contract Player will automatically be cancelled and declared void unless the Club conforms to the exception detailed in Rule 8(B)(i).

(L) A Player shall not be eligible to play for a Team in any special championship, promotion or relegation deciding match (as specified in Rule 12(A)) unless the Player has played 3 league games for that Team in this Competition in the current Playing Season.

L (i) Local Rule: A new player wishing to play in a Cup Semi-final & Final must have been registered with the team 21 days prior to the semi-final fixture date.

(M) (i) Subject to Rule 8(M)(ii), any Club found to have played an ineligible Player in a match or matches where points are awarded shall have the points gained from that match deducted from its record, up to a maximum of 12 points, and have levied upon it a fine (in accordance with the Fines Tariff).

(ii) The Management Committee may vary the sanction as relates to the deduction of points set out at Rule 8(M)(i) only in circumstances where the ineligibility is due to the failure to

obtain an International Transfer Certificate or where the ineligibility is related to the Player's status.

(iii) Where a Club is found to have played an ineligible player in accordance with Rule 8(M)(i) above, the Management Committee may also, at its discretion:

Award the points available in the Competition Match in question to the opponents, subject to the Competition Match not being ordered to be replayed;

Levy penalty points against the Club in default; or

Order that such match or matches be replayed (on such terms as are decided by the Management Committee)

(The following Clause applies to Competitions involving Players in full-time secondary education): -

(N)(i) Priority must be given at all times to school and school organisations activities. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(ii) The availability of children must be cleared with the head teachers (except for Sunday Competitions).

A child under the age of 15 as at midnight on 31 August in a Playing Season, shall not be permitted to play in a Competition Match during that Playing Season where any other Player is older or younger than that child by two years or more.

(O) Local Rule: *Players must be registered by the 1st September to be eligible to play the first game of the season. Clubs failing to fulfil their first fixture due to insufficient registered players will automatically fined as per rule tariff & the points awarded to the opposition. A player is deemed registered when the Club Registration Secretary has received online that the player has been approved. Note rule 8Bi must be complied with.*

(P) Local Rule: *Any player who wishes to register with their respective team must reside within 15 miles (of the crow flies) of the club headquarters. It is the responsibility of the club registration secretary or club secretary to ensure that the player resides within the allowed distance prior to registering online. The headquarters of a club can only be changed at the start end of the season, & prior to the start of the season. This rule does not apply to the Regional Talent Club.*

(Q) Local Rule: *All players are deemed registered with their respective clubs until the 31st May.*

(R) Local Rule: *The maximum number of players per team as follows:*

Mini Soccer U8 = 10: U9 & U10 = 14: 9 v 9 at U11 & U12 = 14: Youth 11-A side at U13 = 16: from U14 - U16 = 18.

(S) Local Rule: *Team officials must ensure that the team ID sheet is available at all matches for team inspection by the Opposition prior to the match commencing. Any player not on the sheet cannot take part in the match. Teams failing to produce the team ID sheet on match days will be fined as per rule tariff & any further breaches by the team will be dealt with at the discretion of the Management Committee. The Management Committee reserve the right to inspect on request the aforementioned forms at any time.*

(T) Local Rule: *All registrations will be checked against the online match report forms.*

(U) Local Rule: *The Management Committee has the power to withhold a souvenir from a player guilty of misconduct. Trophies shall be presented at the Management Committee discretion.*

(V) Local Rule: *Girls are only eligible to play representative football with boys up to the age of 15 (inclusive) in this Competition.*

(Note: For players under the age of 18 the provisions contained in the Football Association Rules will apply.)

CLUB COLOURS. CLUB NAME

9. (A) Every Club must register the colour of its shirts and shorts with the Secretary by [date] who shall decide as to their suitability.

Goalkeepers must wear colours which distinguish them from other Players and the Match Officials.

No Player, including the goalkeeper, shall be permitted to wear black or very dark shirts.

Any Team not being able to play in its normal colours as registered with the Competition shall notify its opponents the colours in which they will play (including the colours of the goalkeeper jersey) at least 5 days before the match.

If, in the opinion of the referee, two Teams have the same or similar colours, the away/home Team shall make the change. Should a Team delay the scheduled time of kick-off for a Competition Match by not having a change of colours they shall be fined (in accordance with the Fines Tariff). Shirts must be numbered.

(B) Any Club wishing to change its name must obtain permission from the Sanctioning Authority and from the Management Committee. Any Club wishing to change its colours during the Playing Season must obtain permission from the Management Committee. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(C) Local Rule: Players names must not be shown on the playing strips.

(D) Local Rule: Kit sponsorship displaying the name of a licensed business or related products of public houses, hotels, bars, night clubs, adult shops & betting shops is not permitted. If a club has any doubt about the appropriateness of sponsorship they should consult the League Secretary. The Management Committee may refuse to permit any kit to be worn in the Competition that they deem inappropriate.

PLAYING SEASON. CONDITIONS OF PLAY, TIMES OF KICK-OFF. POSTPONEMENTS. SUBSTITUTES

10. (A) All Competition Matches shall be played in accordance with the Laws of the Game as determined by the International Football Association Board or, for Mini-Soccer, and 9v9 football, the Rules as set down by The FA.

Clubs must take all reasonable precautions to keep their Grounds in a playable condition. All Competition Matches shall be played on pitches deemed suitable by the Management Committee. If through any fault of the home Team a match has to be replayed, the Management Committee shall have power to order the venue to be changed.

The Management Committee shall have power to decide whether a pitch and/or facilities are suitable for matches in the Competition and to order the Club concerned to play its fixtures on another ground.

Football Turf Pitches are allowed in this Competition. All Football Turf Pitches used must be on The FA's Register of Football Turf Pitches and must be tested (by an accredited test institute) every 3 years and the results passed to The FA. The FA will give a decision on the suitability for use and add the pitch to the Register.

The home Club is also responsible for advising Participants of footwear requirements when confirming match arrangements in accordance with Rule 10(C).

All matches shall have a duration as set out below unless a shorter time is mutually arranged by the two Clubs in consultation with the referee prior to the commencement of the match, and in any event shall be of equal halves.

Matches should be played in accordance with the Laws appropriate to the relevant age group, as laid down by The FA, as detailed below.

For round robin/trophy events, the maximum duration of play per half cannot be exceeded, but the minimum duration of play per half may be adjusted. For trophy events, the Competition may award mementos.

The times of kick-off shall be fixed at the AGM and can only be altered by the mutual consent of the two competing Clubs prior to the scheduled date of the match with written notification given to the Secretary at least 7 days prior.

Referees must order matches to commence at the appointed time and must report all late starts to the Secretary.

The home Team must provide goal nets, corner flags and at least two footballs fit for play and the referee shall make a report to the Secretary if the footballs are unsuitable. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(A) (i) Local Rule: Kick Off Times – No games must start before 10am or after 3pm. All U13 games shall kick off at 10.30am, U14 games shall kick off at 12.30pm & all U15/U16 games shall kick off at 2.pm unless the league is notified in writing giving 28 days' notice to the Referees Appointment Secretary. (See Rule 13A (i) & (ii))

A (ii) Local Rule: Development Leagues. The league will provide Development Football for U8, U9 & U10 in mini soccer formats & 9 v9 football at U11 & U12. All age groups (except U12) will not play for points & NO results or league table/rankings will be published. Age groups U10, U11 & U12 will be eligible to enter cup competitions.

(iii) Local Rule: For Mini Soccer – U8 Age Group duration of each game: 4 x 10 minutes. U9 Age Group duration of each Game: 4 x 15 minutes. U10 Age Group duration of each game: 3 x 15 minutes.

(B) Except by permission of the Management Committee all Competition Matches must be played on the dates originally fixed but priority shall be given to The FA and parent County Association Cup Competitions. All other matches must be considered secondary. Clubs may mutually agree to bring forward a match with the consent of the (Fixtures) Secretary. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

In the case of a revised fixture date, the Clubs must be given by the Competition 5 clear days' notice of the match (unless otherwise mutually agreed).

(C) An Officer of the home Club must give notice of full particulars of the location of, and access to, the group and time of kick-off to the Match Officials and the secretary of the opposing Club at least 5 clear days prior to the playing of the match. If not so provided, the away Club shall seek such details and report the circumstances to the Competition. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(D) The minimum number of Players that will constitute a Team for a Competition Match is as follows:

Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(E) (i) In Competitions where points are awarded home and away matches shall be played. In the event of a Club failing to keep its engagement the Management Committee shall have the power to impose a fine (in accordance with the Fines Tariff), deduct points from the defaulting Club, award the points from the match in question to the opponents, order the defaulting Club to pay any expenses incurred by the opponents or otherwise deal with them except the award of goals. Notwithstanding the foregoing home and away provision, the Management Committee shall have power to order a match to be played on a neutral ground or on the opponent's Ground if they are satisfied that such action is warranted by the circumstances.

(ii) Any Club unable to fulfil a fixture or where a fixture has been postponed for any reason must, without delay, give notice to the (Fixtures) Secretary, the Competition Referees Appointments Secretary, the secretary of the opposing Club and the Match Officials.

(iii) In the event of a match not being played or abandoned owing to causes over which neither Club has control, it shall be played in its entirety on a date to be mutually agreed by the two Clubs and approved by the Management Committee. Failing such agreement and notification to the (Fixtures) Secretary within 7 days the Management Committee shall have the power to order the match to be played on a named date or on or before a given date.

Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(iv) The Management Committee shall review all matches abandoned in cases where it is consequent upon the conduct of either or both Teams. Where it is to the advantage of the Competition and does no injustice to either Club, the Management Committee shall be empowered to order the score at the time of the abandonment to stand. In all cases where the Management Committee are satisfied that a match was abandoned owing to the conduct of one Team or its Club member(s) they shall be empowered to award the points for the match to the opponent. No fine(s) can be applied by the Management Committee for an abandoned match.

(v) The Management Committee shall review any match that has taken place where either or both Teams were under a suspension imposed upon them by The FA or Affiliated Association. In each case the Team that was under suspension would be dealt with in the same manner as if they had participated with ineligible players in accordance with Rule 8(M) (i) above. Where both Teams were under suspension the match must be declared null and void and shall not be replayed.

(F) A Club may at its discretion and in accordance with the Laws of the Game use substitute Players in any match in this Competition.

Where a Competition does not allow repeat substitutes:

For Under 17s and Under 18s – [up to 3 may be selected from 3 substitute Players] [up to 4 may be selected from 4 substitute Players] [up to 5 may be selected from 5 substitute Players].

Where a Competition does allow repeat substitutes:

For Under 11s – Under 16s – [U11-U13 up to 5 may be selected from 5 substitute Players] [U14-U16 up to 5 may be selected from 7 substitute Players]. A Player who has been substituted becomes a substitute and may replace any Player at any time subject to the substitution being carried out in accordance with Law 3 of the Laws of Association Football.

For Mini-Soccer – any number of substitutions may be used at any time with the permission of the Match Official. Entry onto the field of play will only be allowed during a stoppage in play. A Player who has been replaced may return to the play as a substitute for another Player. A Team must not have a match day squad greater than double the size of its Team in an age group.

In Youth Football only, the referee shall be informed of the names of the substitutes not later than 15 minutes before the start of the match and a Player not so named may not take part in the match.

A Player who has been selected, appointed or named as a substitute before the start of the match but does not actually play in the game shall not be considered to have been a Player in that game within the meaning of Rule 8 of this Competition.

(G) The half time interval shall be of 10 minutes' duration, but it shall not exceed 15 minutes. The half time interval may only be altered with the consent of the Match Officials.

(H) The Teams taking part in Youth Football shall identify a Team captain who shall wear an armband and shall have a responsibility to offer support in the management of the on-field discipline of his/her teammates. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(H) (i) Local Rule: The competition shall require all players and club officials to comply with the SJFL's Respect Marshall and Respect Presentaion Codes.Failure to comply with this Rule will result in a fine (in accordance with the fine tariff).

(I) Local Rule: No manager or assistant shall be allowed to manage or coach a second team within this league.

(J) (i) Local Rule Cup Competitions – For the purpose of all Cup Competitions.

1. SJFL has discontinued its traditional cup rounds format knockout competitions format, namely the League Cup &

Consolation Cup & replaced these with a Cup Group format- similar to Champions/Europa Cup Group format – covering the respective age Groups of teams rather than by the separate divisions within groups. The `Group` stages will produce teams to go forward to the semi-finals (the draw will be made using FA Full-Time) of two new competitions. The four winning teams from each group stage will contest the League Cup & the second placed teams will contest the Consolation Cup. Rules for the new competitions are as follows (see 2-7).

2. Entry to the cup competitions is automatic- forms part of the club/team affiliation to SJFL.

3. For each group all teams will be in a single pool of teams & the draw will be made using FA-Full-Time.

4. For each group (not divisions) teams will be listed in order points won (using FA Full-Time) the previous season – (e.g) U12`s age group team points position will be the basis for the seeding of the U13 Cup Group & so on - & teams then placed in groups by order.

5. For each age group, Group A will be made up of the top points teams from the previous season's order of points table, Group B from the next tier of teams from the previous season & so on.

6. At the group stage four or more teams in a group will play each other once, three teams in a group will play each other twice (the draw will be run using FA Full-Time)

7. Due to indeterminate number of teams at any one age group the Management Committee reserves the right to decide how many teams are in a group & how many groups are needed.

8. These rules do not apply to the Shropshire Charity Cup Competitions for U12-U16. (See Rule 10 J(ii)

9. These rules could be applied to the SJFL U10 & U12 Charity Trophy/ Festivals but the leagues Management Committee reserves the right to decide how many teams in a group & how many groups are needed. All ties will be played on the dates specified. With the exception of postponements due to weather or official school Activities, these games will be played on a date fixed by the fixture secretary. Failure to comply will result in the offending team forfeiting the tie in favour of their opponents.

The duration of play shall be

Under 10: 40 minutes (20 minutes each way)

Under 11/12: 60 minutes (30 minutes each way)

Under 13/14: 70 minutes (35 minutes each way)

Under 15/16: 80 minutes (40 minutes each way)

Should the scores be equal after the stated time of play 10 minutes of extra time will be played. If after extra time the scores are still equal, then penalties will take place under F.I.F.A rules to decide. No player can play for more than one club in any particular Cup Competition during that season. (accepting that the League & Consolation Cup are separate

Competitions) A player in order to play in a cup-tie must have signed for his/her Club according to League Rules, & to play in a semi-final or final must have been registered with the league as per league rules 21 days prior to the Cup conference date.

Semi-finals will be played on the grounds of the team drawn first in the pairing. Where there is a clash of fixtures the precedence for determining which match is played is as follows school matches (although these normally do not take place on a Sunday), Charity Cup matches, League Cup matches, Consolation Cup matches.

Once 5 days' notification has been given of the forthcoming fixture as per Rule 10 C, where the home teams pitch is considered unfit & the away team's pitch is available & fit for use by 7.pm on the Thursday prior to the scheduled fixture, the fixture will be reversed. The original home team will take responsibility for the organisation of the referee. The use of artificial pitches is permitted for Cup Competitions, but not sand based pitches.

(J) (ii) For the purpose of the Shropshire Charity Cup (except for U10 & U11). All teams will be automatically entered unless the team has notified the League Secretary by the 1st September. The names of all entered shall be placed in one lot & shall be drawn from such a lot in couples at a time. The couples shall compete with each other & the name of the winning team shall be placed in a lot, drawn in couples & compete as in the first tie & so on until the semi-finals are reached. In each round the tie to be played on the grounds of the team first drawn or as otherwise directed by the Management Committee. Semi-final ties to be played on the ground of the team drawn first or at the discretion of the Management Committee. Finals will be played on neutral grounds as decided by the Management Committee. Ties will be played on the Dates specified. With the exception of call offs due to weather & school activities (see Rule 10 (K)) ties will be played on the dates specified. Failure to comply will result in the offending team forfeiting the tie in favour of their opponents.

The duration of play shall be

Under 10: 40 minutes (20 minutes each way)

Under 11/12: 60 minutes (30 minutes each way)

Under 13/14: 70 minutes (35 minutes each way)

Under 15/16: 80 minutes (40 minutes each way)

Should the scores be equal after the stated time of play 10 minutes of extra time will be played. If after extra time the scores are still equal, then penalties will take place under F.I.F.A rules to decide. No player can play for more than one club in any particular Cup Competition during that season. (accepting that the League & Consolation Cup are separate Competitions) A player in order to play in a cup-tie must have signed for his/her Club according to League Rules, & to play in a semi-final or final must have been registered with the league as per league rules 21 days prior to the Cup conference date. Semi-finals will be played on the grounds of the team drawn first in the pairing. Where there is a clash of fixtures the precedence for determining which match is played is as follows school matches (although these normally do not take place on a Sunday), Charity Cup matches, League Cup matches, Consolation Cup matches.

(K) Local Rule: Conference dates for all Cup Competitions must strictly adhered to (This rule supersedes Rule 10 (C)for cup competitions). Any teams failing to play on dates specified will automatically forfeit the game with the exception of call offs due to weather conditions or school activities. To postpone a Cup Fixture due to official school activities the League Secretary must receive 14 days notice of postponement. An official letter from the school is also required and must state players names and date(s) of school activity.

(L) Local Rule: All matches will be played on a Sunday unless otherwise stated or having received prior agreement by the League Management Committee. The Fixture Secretary will have the power to allocate midweek fixtures as it deemed appropriate.

(M) Local Rule: The League Management Committee will decide the Divisional structure for each age group irrespective of number of entries with the exception that no division will exceed 10 teams in accordance with the requirements/guidelines under the CS for leagues.

REPORTING RESULTS

11.(A) The (Fixtures) Secretary must receive within 3 days of the date played, the result of each Competition Match in the prescribed manner. This must include the forename(s) and surname of the Team Players (in block letters) and also the referee markings required by Rule 13, or any other information required by the Competition. Failure to do so will incur a fine (in accordance with the Fines Tariff).

(B) The Home Club/both Clubs shall telephone/SMS/email/notify the result of each match by 11pm. Clubs in default shall be fined (in accordance with the Fines Tariff).

(C) The match result notification, correctly completed, shall be signed by an Officer of the Club, or as prescribed by the Competition. Failure to do so will result in a fine (in accordance with the Fines Tariff).

(D) The Competition and Clubs are permitted to collect but NOT publish results or any grading tables for fixtures involving Under 7s, Under 8s, Under 9s, Under 10s, and Under 11s. Any Competition failing to abide by this Rule will be dealt with by the Sanctioning Authority, and any Club failing to abide by this Rule will be fined (in accordance with the Fines Tariff). The Competition and Clubs are permitted to collect and publish results for trophy events.

(E) The Competition may require a Club to confirm that a set fixture has been played. A fine (in accordance with the Fines Tariff) may be imposed for a breach of this Rule.

(F) Local Rule: Both clubs shall SMS the result of each match to the FA Full-Time site between 12pm & 12am on the day the fixture took place. Clubs in default will be fined as per fine tariff.

Both teams will text their results by SMS & Result/Respect sheets will be completed on the FA Full-Time site. Result & Respect sheets must be recorded within a 48-hour period. Failure to comply will result in a fine as per fine tariff.

(G) Postponement of fixtures should be reported in the same manner. Failure by either team to complete the online result form & respect form within the stipulated time shall result in an automatic fine as per rule tariff for each infringement of this rule.

The boxes 1 to 100 on the **Respect** form are for clubs to mark the opponents team, managers, supporters & the performance of the referee. Marks of 30 & under must be accompanied by a brief statement. Failure to comply will incur a fine as per fine tariff.

The SJFL Local Rules fully cover the way we report our results by SMS/Full-Time or by online result/respect sheets for all Age Groups & approved by the SFA.

DETERMINING CHAMPIONSHIP

12.(A) In Competitions where points are awarded, Team rankings within the Competition will be decided by points with three points to be awarded for a win and one point for a drawn match. The Teams gaining the highest number of points in their respective divisions at the conclusion shall be adjudged the winners. Matches must not be played for double points.

In the event of two or more Teams being equal on points Team rankings may be determined by deciding match(es) played under conditions determined by the Management Committee, or the position shared.

(B) Rule 12 (B) of the SCOYR is not applicable to this league.

(C) In the event of a Team not completing 100% of its fixtures for the Playing Season all points obtained by or recorded against such defaulting Team shall be expunged from the Competition table.

REFEREES

13.(A) Registered referees (and assistant referees where approved by The FA or County FA) for all Competition Matches shall be appointed in a manner approved by the Management Committee and by the Sanctioning Association(s).

(A) (i) Local Rule: *Registered referees shall be appointed for all U13, U14, U15 & U16 age groups in a manner approved by the Management Committee & by the sanctioning association. All other age groups must use a qualified & registered referee for all league fixtures.*

(A) (ii) All U13 matches shall kick off at 10.30am, all U14 matches shall kick off at 12.30pm & all U15 & U16 matches shall kick off at 2pm unless the league is notified in writing by the home club/team giving 28 days' notice of the change to the League Referee Appointment Secretary where the kick off time will be 11am.

(B) In cases where there are no officially appointed Match Officials in attendance the Clubs shall agree upon a referee. An individual thus agreed upon shall, for that game, have the full powers, status and authority of a registered referee.

(C) Where assistant referees are not appointed each Team shall provide a Club assistant referee. Failure to do so will result in a fine (in accordance with the Fines Tariff) being imposed on the defaulting Club.

(D) The appointed referee shall have power to decide as to the fitness of the Ground in all matches and the decision shall be final subject to either in the case of a ground of a Local Authority or the owners of a Ground, the representative of that body is the sole arbiter and whose decision must be accepted.

(E) Subject to any limits/provisions laid down by the Sanctioning Association, Match Officials appointed under this Rule shall be paid their fees and expenses in accordance with the Fees Tariff.

Match Officials will be paid their fees and/or expenses by the home Club unless otherwise ordered by the Management Committee. Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

(E)(i) Local rule: Subject to any limits/provisions laid down by the sanctioning Association, Match Officials appointed under this rule shall be entitled to the following match fees:

For U8 – U10 matches shall be £10, U11 – U12 matches Referee £15 Assistant Referees £10, U13 – U15 matches Referees £20 Assistant Referees £15 & U16 matches where the fees will be Referee £25, Assistant Referee £20 (inclusive of travel expenses and any other permitted expenses actually incurred).

The Home Club shall pay the Officials their fees and expenses before/immediately after the match.

(F) In the event of a match not being played because of circumstances over which the Clubs have no control, the Match Officials, if present, shall be entitled to full fee plus expenses. Where a match is not played owing to one Club being in default, that Club shall be ordered to pay the Match Officials, if they attend the Ground, their full fee and expenses. Failure to comply with the Rule will result in a fine (in accordance with the Fines Tariff).

(G) A referee not keeping his or her engagement, and failing to give a satisfactory explanation as to their non-appearance, may be reported to the Association with which he or she is registered.

CONTINUATION OF MEMBERSHIP OR WITHDRAWAL OF A CLUB

14.(A) Any Club wishing to resign from the Competition must do so at least 14 days before the AGM. Failure to do so will result in a fine (in accordance with the Fines Tariff).

(B) The Management Committee shall have the discretion to deal with a Team being unable to start or complete its fixtures for a Playing Season, including but not limited to, issuing a fine (in accordance with the Fines Tariff).

(C) In addition to the powers of the Management Committee pursuant to Rule 5(I), in the event of a member Club failing to discharge all its financial obligations to the Competition in excess of £50, the Management Committee are empowered to refer the debt under The FA Football Debt Recovery provisions.

PROTESTS AND COMPLAINTS

15. (A)(i) All questions of eligibility, qualifications of Players or interpretations of the Rules shall be referred to the Management Committee or a sub-committee duly appointed by the Management Committee.

(ii) Objections relevant to the dimensions of the pitch, goals, flag posts or other facilities of the venue will not be entertained by the Management Committee unless a protest is lodged with the referee before the commencement of the match.

(B) Except in cases where the Management Committee decide that there are special circumstances, protests and complaints (as set out more fully at Rule 15(A) above) (which must contain full particulars of the grounds upon which they are founded) must be lodged in duplicate with the Secretary within 7 days (excluding Sundays) of the match or occurrence to which they refer. A protest or complaint shall not be withdrawn except by permission of the Management Committee. A member of the Management Committee who is a member of any Club involved shall not be present (except as a witness or representative of his Club) when such protest or complaint is being determined.

(C) No protest of whatever kind shall be considered by the Management Committee unless the complaining Club shall have deposited with the Secretary a sum of £25 in accordance with the Fees Tariff. This may be forfeited in whole or in part in the event of the complaining or protesting Club losing its case. The Competition shall have power to order the defaulting Club or the Club making a losing or frivolous protest or complaint to pay the expenses of the inquiry or to order that the costs to be shared by the parties.

(D) All parties to a protest or complaint must receive a copy of the submission and must be afforded an opportunity to make a statement at least 7 days prior to the protest or complaint being heard.

(i) All parties must have received 14 days' notice of the hearing should they be instructed to attend.

(ii) Should a Club elect to state its case in person then they should forward a deposit of £25 and indicate such when forwarding the written response.

(E) If so requested by all parties concerned, the Management Committee may determine any disputes, protests, appeals, claims or complaints between two Clubs in which event both Clubs shall send a non-returnable fee. Such determination shall be final and binding upon the parties concerned. The procedure for such determination shall be determined by the Management Committee.

BOARD OF APPEAL

16. Any appeal against a decision of the Management Committee must be lodged with the Sanctioning Authority within 14 days of the posting of the written notification of the decision

causing the appeal, accompanied by a fee as set out in the Fees Tariff, which may be forfeited in the event of the appeal not being upheld. A copy of the appeal must also be sent to the Secretary. The procedure for the appeal shall be determined by the Sanctioning Authority, in such respect the Sanctioning Authority may (but is not obliged to):

Invite submissions by the parties involved;
Convene a hearing to hear the appeal;
Permit new evidence; or

Impose deadlines as are appropriate.

Any appeal shall not involve a rehearing of the evidence considered by the Management Committee. No appeal can be lodged against a decision taken at an Annual or Special General Meeting unless this is on the ground of unconstitutional conduct.

(B) Local Rule: Reports of players in all age groups being either cautioned or dismissed from the field of play will be dealt with by the Shropshire FA in accordance with the Schedule Of General Standards Of Punishment For Players Of Member Clubs in force at the time. The Management Committee shall have the power to withhold a souvenir from any player guilty of misconduct.

EXCLUSION OF CLUBS OR TEAMS, MISCONDUCT, CLUBS, OFFICIALS, PLAYERS

17.(A) At the AGM or Special General Meeting called for the purpose in accordance with the provisions of Rule 19, notice of motion having been duly circulated on the agenda, the accredited delegates present shall have the power to exclude any Club or Team from further membership which must be supported by (more than) two-thirds (2/3) of those present and voting. Voting on this point shall be conducted by ballot.

(B) At the AGM, or at a Special General Meeting called for the purpose, in accordance with the provisions of Rule 19, the accredited delegates present shall have the power to exclude from further participation in the Competition any Club or Team whose conduct has, in their opinion, been undesirable, which must be supported by (more than) two-thirds (2/3) of those present and voting. Voting on this point shall be conducted by ballot. A Club whose conduct is the subject of the vote being taken shall be excluded from voting.

(C) Any Officer or member of a Club proved guilty of either a breach of Rule, other than field offences, or of inducing or attempting to induce a Player or Players of another Club in the Competition to join them shall be liable to expulsion or such penalty as a General Meeting or Management Committee may decide, and their Club shall also be liable to expulsion in accordance with the provisions of Clauses (A) and (B) of this Rule.

TROPHY: - LEGAL OWNERS, CONDITIONS OF TAKING OVER, AGREEMENT TO BE SIGNED. AWARDS.

18.(A) The following agreement shall be signed on behalf of the winners of the Cup or Trophy: -

“We A [name] and B [name], the Chairman and Secretary of [] FC (Limited), members of and representing the Club, having been declared winners of [] Cup or Trophy, and it having been delivered to us by the Competition, do hereby on behalf of the Club jointly and severally agree to return the Cup or Trophy to the Competition Secretary on or before [FEBRUARY LEAGUE MEETING]. If the Cup or Trophy is lost or damaged whilst under our care we agree to refund to the Competition the amount of its current value or the cost of its thorough repair.”

Failure to comply will result in a fine (in accordance with the Fines Tariff).

(B) At the close of each Competition awards may/shall be made to the winners and runners-up if the funds of the Competition permit.

SPECIAL GENERAL MEETINGS

19. Upon receiving a requisition signed by two-thirds (2/3) of the Clubs in membership the Secretary shall call a Special General Meeting.

The Management Committee may call a Special General Meeting at any time.

At least 7 days' notice shall be given of a meeting under this Rule, together with an agenda of the business to be transacted at such meeting.

Each member Club shall be empowered to send two delegates to all Special General Meetings. Each Club shall be entitled to one vote only. Officers and Management Committee members shall be entitled to attend and vote at all Special General Meetings.

Any continuing member Club failing to be represented at a Special General Meeting without satisfactory reason being given shall be fined (in accordance with the Fines Tariff).

ALTERATION TO RULES

20. (A) Alterations, for which consent has been given by the Sanctioning Association, shall be made to these Rules only at the AGM or at a Special General Meeting specially convened for the purpose called in accordance with Rule 19. Any alteration made during the Playing Season to the Rule relating to the qualification of Players shall not take effect until the following Playing Season.

Notice of proposed alterations to be considered at the AGM shall be submitted to the Secretary by the 28th of February in each year. The proposals, together with any proposals by the Management Committee, shall be circulated to the Clubs by [April] and any amendments thereto shall be submitted to the Secretary by [May]. The proposals and proposed amendments thereto shall be circulated to Clubs with the notice of the AGM. A proposal to change a Rule shall be carried if a majority of those present, entitled to vote and voting are in favour.

A copy of the proposed alterations to Rules to be considered at the AGM or Special General Meeting shall be submitted to the Sanctioning Authority or The FA (as applicable) [30] days prior to the date of the meeting.

(B) Local Rule Any alterations or additions decided upon at any meetings shall not become operative until the approval of the Association issuing sanction shall have been obtained.

FINANCE

21. (A) The Management Committee shall determine with which bank or other financial institution the funds of the Competition will be lodged.

(B) All expenditure in excess of £100 shall be approved by the Management Committee. Cheques shall be signed by at least two Officers nominated by the Management Committee.

(C) The financial year of the Competition will end on the 30th of April.

(D) The books, or a certified balance sheet, of a Competition shall be prepared and shall be audited/verified annually by some suitably qualified person(s) who shall be appointed at the AGM.

INSURANCE

22. All Clubs must have public liability insurance cover of at least ten million pounds (£10,000,000). Failure to comply with this Rule will result in a fine (in accordance with the Fines Tariff).

DISSOLUTION

23.(A) Dissolution of the Competition shall be by resolution approved at a Special General Meeting by a majority of three quarters (3/4) of the members present and shall take effect from the date of the relevant Special General Meeting.

(B) In the event of the dissolution of the Competition, the members of the Management Committee are responsible for the winding up of the assets and liabilities of the Competition.

(C) The Management Committee shall deal with any surplus assets as follows:

(i) Any surplus assets, save for a Trophy or any other presentation, remaining after the discharge of the debts and liabilities of the Competition shall be transferred only to another Competition or Affiliated Association or The Football Association Benevolent Fund or to such other charitable or benevolent object in the locality of the Competition as determined by resolution at or before the time of winding up, and approved in writing by the Sanctioning Association.

(ii) If a Competition is discontinued for any reason a Trophy or any other presentation shall be returned to the Donor if the conditions attached to it so provide or, if not, dealt with as the Sanctioning Association may decide.

24. RULES BINDING ON CLUBS

Local Rules:

1. The League Handbook must be carried to all matches, failure to do so will result in the matter of a fine as per fine tariff or being dealt with the Management Committee.

2. Each club in the league must provide a suitable weekend telephone number. Failure to comply with result in the matter being dealt with by the Management Committee.

25. SAFE GUARDING CHILDREN.

1. Local Rule: All teams must be supervised by TWO responsible adults who are members of the club & both of whom holds a valid FA DBS, & has completed the FA Safeguarding Children Workshop within the previous 3-year period. Both manager & coach shall have completed the FA Emergency Aid course within the previous 3-year period or holds another recognised first aid qualification from their place of work i.e. police, fire service, ambulance service, paramedic, nurse or doctor.

At least one of the adults should hold a FA Level 1 Coaching badge.

*All teams **MUST** carry adequate First Aid kits at all fixtures & training. (The use of freeze spray or pain killing sprays is forbidden).*

Clubs failing to provide responsible supervision & comply with the Competition shall be liable to be fined as per fine tariff or otherwise dealt with by the Management Committee.
